

ACKNOWLEDGEMENT OF RISK, RELEASE & INDEMNITY AGREEMENT (“AGREEMENT”)

I, _____, hereby acknowledge that I have voluntarily applied to the Village of Indian Hill, Ohio (hereinafter “Village”) to be a Member of the Indian Hill Shooting Club (hereinafter “IHSC”) to engage in or to observe shooting and other activities at the IHSC. I acknowledge and understand that shooting activities are inherently dangerous, and involve both known and unanticipated risks which could result in damage to or destruction of property and bodily injury, including death, of me or of other persons.

As lawful consideration for being permitted by the Village and the IHSC to enter onto the IHSC shooting range, to use shooting range facilities or equipment and to engage in or observe shooting and other activities at the shooting range, as either a Member or a Guest, I agree as follows:

I EXPRESSLY AGREE TO ACCEPT AND ASSUME ANY AND ALL RISKS EXISTING ON THE IHSC SHOOTING RANGE AND IN ENTERING ONTO THE SHOOTING RANGE AND IN USING THE SHOOTING RANGE FACILITIES OR EQUIPMENT AND IN ENGAGING IN OR OBSERVING SHOOTING OR OTHER ACTIVITIES AT THE SHOOTING RANGE.

I agree that I will ensure that each of my Guests read and sign the IHSC RELEASE AND INDEMNITY form.

I agree to abide by all IHSC Rules and Policies, and to ensure that my Guests do so as well.

I agree that I, on behalf of myself and my next of kin, heirs, guardians, representatives and assigns HEREBY RELEASE AND FOREVER DISCHARGE, INDEMNIFY, HOLD HARMLESS AND AGREE NOT TO SUE the IHSC and the Village, and their respective officers, directors, agents, employees, members or volunteers, from and against any and all direct and third-party claims, demands, damages, expenses or liability of any kind whatsoever, including reasonable attorneys’ fees and costs, that I, my next of kin, heirs, guardians, representatives or assigns, my Guests, or anyone else, may have for property damage, bodily injury or death, whether suffered by me, by my Guests, or by anyone else, resulting from me or my Guests entering on to the shooting range, using the shooting range facilities or equipment, or engaging in or observing shooting and other activities at the shooting range, even if such claims, demands, damages, expenses or liability result partially or wholly from any act or acts, even any negligent act or omission to act by the IHSC or the Village.

I FURTHER ACKNOWLEDGE AND AGREE that this Agreement is intended to be as broad and inclusive as permitted by law, and that if any provision or portion is held to be invalid, void or otherwise unenforceable, I agree and intend that the remaining provisions or portion shall continue and remain in full legal force and effect.

I FURTHER ACKNOWLEDGE AND AGREE that it is my understanding and intent that this Agreement shall remain in full force and effect from the date of execution and ever after and shall be applicable to each and every occasion that I or my Guests enter on to the shooting range, use the shooting range facilities or equipment or engage in or observe shooting and other activities at the shooting range.
